SUMMARY

INTRODUCTION

This Interconnection Facilities Study (IFS) for Interconnection Request <u>GEN-2016-061/IFS-2016-001-15</u> is for a <u>250.7</u> MW generating facility located in <u>Garfield and Noble Counties</u>, <u>Oklahoma</u>. The Interconnection Request was studied in the <u>DISIS-2016-001</u> Impact Study and Impact Restudies for <u>Energy Resource Interconnection Service (ERIS</u>). The Interconnection Customer's original requested in commercial operation date is <u>12/1/2017</u> and the revised commercial operation date in the Facilities Study Agreement is <u>12/01/2018</u>.

The interconnecting Transmission Owner, <u>Oklahoma Gas & Electric (OKGE)</u>, performed a detailed IFS at the request of SPP. The full report is included in Appendix A. SPP has determined that full Interconnection Service will be available after the assigned transmission owner interconnect facilities (TOIF), non-shared network upgrades, shared network upgrades, contingent network upgrades, previously allocated, and affected system upgrades that are required for full interconnection service are completed.

The primary objective of the IFS is to identify necessary Transmission Owner Interconnection Facilities, Network Upgrades, other direct assigned upgrades, cost estimates, and associated upgrade lead times needed to grant the requested Interconnection Service.

PHASE(S) OF INTERCONNECTION SERVICE

It is not expected that Interconnection Service will occur in phases. However, full Interconnection Service will not be available until all Interconnection Facilities and Network Upgrade(s) can be placed in service.

CREDITS/COMPENSATION FOR AMOUNTS ADVANCED FOR NETWORK UPGRADE(S)

Interconnection Customer shall be entitled to compensation in accordance with Attachment Z2 of the SPP OATT for the cost of SPP creditable-type Network Upgrades, including any tax gross-up or any other tax-related payments associated with the Network Upgrades, that are not otherwise refunded to the Interconnection Customer. Compensation shall be in the form of either revenue credits or incremental Long Term Congestion Rights (iLTCR).

INTERCONNECTION CUSTOMER INTERCONNECTION FACILITIES

The Generating Facility is proposed to consist of <u>one hundred and nine (109) GE 2.3 MW wind turbines</u> for a total generating nameplate capacity of <u>250.7 MW</u>.

The Interconnection Customer's Interconnection Facilities to be designed, procured, constructed, installed, maintained, and owned by the Interconnection Customer at its sole expense include:

- 34.5 kV underground cable collector circuits;
- 34.5 kV to 345 kV transformation substation with associated 34.5 kV and 345 kV switchgear;
- One (1) 34.5/345 kV 170/220/280 MVA (ONAN/ONAF/ONAF) step-up transformer to be owned and maintained by the Interconnection Customer at the Interconnection Customer's substation;
- Approximately a half (0.5) mile overhead 345 kV line to connect the Interconnection Customer's substation to the Point of Interconnection ("POI") at the 345 kV bus at new Transmission Owner substation ("Woodring Sooner 345kV") that is owned and maintained by Transmission Owner;
- All transmission facilities required to connect the Interconnection Customer's substation to the POI;
- Equipment at the Interconnection Customer's substation necessary to maintain a composite power delivery at continuous rated power output at the high-side of the generator substation at a power factor within the range of 95% lagging and 95% leading in accordance with Federal Energy Regulatory Commission (FERC) Order 827. Additionally approximately 11.7 Mvars¹ of reactors will be required to compensate for injection of reactive power into the transmission system under no/reduced generating conditions. The Interconnection Customer may use inverter manufacturing options for providing reactive power under no/reduced generation conditions. The Interconnection Customer will be required to provide documentation and design specifications demonstrating how the requirements are met.

The Interconnection Customer shall coordinate relay, protection, control, and communication system configurations and schemes with the Transmission Owner.

¹ This approximate minimum reactor amount is needed for the current configuration of GEN-2016-061 as studied in the DISIS-2016-001 Impact Study and Restudies.

TRANSMISSION OWNER INTERCONNECTION FACILITIES AND NON-SHARED NETWORK UPGRADE(S)

To facilitate interconnection, the interconnecting Transmission Owner will perform work as shown below necessary for the acceptance of the Interconnection Customer's Interconnection Facilities.

Table 1 and **Table 2** lists the Interconnection Customer's estimated cost responsibility forTransmission Owner Interconnection Facilities (TOIF) and Non-Shared Network Upgrade(s) andprovides an estimated lead time for completion of construction. The estimated lead time begins whenthe Generator Interconnection Agreement has been fully executed.

All studies have been conducted assuming that higher-queued Interconnection Request(s) and the associated Network Upgrade(s) will be placed into service. If higher-queued Interconnection Request(s) withdraw from the queue, suspend or terminate service, the Interconnection Customer's share of costs may be revised. Restudies, conducted at the customer's expense, will determine the Interconnection Customer's revised allocation of Shared Network Upgrades.

Certain Contingent Network Upgrades are **currently not the cost responsibility** of the Interconnection Customer but will be required for full Interconnection Service.

Depending upon the status of higher- or equally-queued customers, the Interconnection Request's inservice date is at risk of being delayed or Interconnection Service is at risk of being reduced until the inservice date of these Previous Network Upgrades.

AFFECTED SYSTEM UPGRADE(S)

To facilitate interconnection, the Affected System Transmission Owner will be required to perform the facilities study work as shown below necessary for the acceptance of the Interconnection Customer's Interconnection Facilities. **Table 6** displays the current impact study costs as part of the Affected System Impact review. The Affected System facilities study could provide revised costs and will provide each Interconnection Customer's allocation responsibilities for the upgrades.

The Interconnection Customer's estimated cost responsibility is summarized in the table below.

Summary

Pursuant to the tariff and at the request of the Southwest Power Pool (SPP), Oklahoma Gas and Electric (OG&E) performed the following Facility Study to satisfy the Facility Study Agreement executed by the requesting customer for SPP Generation Interconnection request Gen-2016-061. The request for interconnection was placed with SPP in accordance SPP's Open Access Transmission Tariff, which covers new generation interconnections on SPP's transmission system. The requirements for interconnection consist of building a new EHV substation, with three new 345kV breakers and a terminal for the wind farm line. The total cost for OKGE to build the new substation with three new 345kV breakers, and three line terminals in a new EHV Substation, the interconnection facility, is estimated at \$11,000,000.

Introduction

The Southwest Power Pool has requested a Facility Study for the purpose of interconnecting a wind generating facility within the service territory of OG&E Electric Services (OKGE) in Noble County Oklahoma. The proposed 345kV point of interconnection is at a new EHV Substation in Noble County. This substation will be owned by OKGE. The cost for adding a new 345kV terminal to a new EHV Substation, the required interconnection facility, is estimated at \$892,334.

Network Constraints in the Southwest Public Service (SPS), OKGE and Western Farmers Electric Cooperative (WFEC) systems may be verified with a transmission service request and associated studies.

Other Network Constraints in the American Electric Power West (AEPW), Southwest Public Service (SPS), OKGE, and Western Farmers Electric Cooperative (WFEC) systems may be verified with a transmission service request and associated studies.

Interconnection Facilities

The primary objective of this study is to identify attachment facilities. The requirements for interconnection consist of adding a new 345kV terminal in a new EHV Substation. This 345kV addition shall be constructed and maintained by OKGE. It is assumed that obtaining all necessary right-of-way for the line into the new OKGE 345kV substation facilities will be performed by the interconnection customer.

The total cost for OKGE to add a new 345kV terminal in a new EHV Substation, the interconnection facility, is estimated at \$892,334. This cost does not include building the 345kV line from the Customer substation into the new EHV Substation. The Customer is responsible for this 345kV line up to the point of interconnection. This cost does not include the Customer's 345-34.5kV substation and the cost estimate should be determined by the Customer.

This Facility Study does not guarantee the availability of transmission service necessary to deliver the additional generation to any specific point inside or outside the Southwest Power Pool (SPP) transmission system. The transmission network facilities may not be adequate to deliver the additional generation output to the transmission system. If the customer requests firm transmission service under the SPP Open Access Transmission Tariff at a future date, Network Upgrades or other new construction may be required to provide the service requested under the SPP OATT.

The costs of interconnecting the facility to the OKGE transmission system are listed in Table 1.

Short Circuit Fault Duty Evaluation

It is standard practice for OG&E to recommend replacing a circuit breaker when the current through the

breaker for a fault exceeds 100% of its interrupting rating with re-closer de-rating applied, as determined

by the ANSI/IEEE C37.5-1979, C37.010-1979 & C37.04-1979 breaker rating methods.

For this generator interconnection, no breakers were found to exceed their interrupting capability after the

addition of the Customer's 250MW generation and related facilities. OG&E found no breakers that

exceeded their interrupting capabilities on their system. Therefore, there is no short circuit upgrade costs

associated with the Gen-2016-061 interconnection.


